We encourage you to bring your own seasoned horse that ties well, is calm for having his/her feet handled (for the sake of your back), and does not have significant hoof pathology (our intent is to demonstrate normal introductory hoof trims not treat horses with serious hoof pathology in this clinic)

#### **REGISTRATION CHECKLIST:**

- ❖ Fully completed registration form
- ❖ Copy of Negative Coggins for each horse attending
- ❖ Signed release form for each person attending (must be signed by parent if attendee/rider is less than 18 years of age), no children under 15 permitted.
- ❖ Check to include all necessary fees made out to 'Stables of Shiloh Farms'

#### **ATTENDANCE CHECKLIST:**

- ❖ Refreshments of your choice (overestimate what you will need - trimming is strenuous work!!!)
- ❖ Thin but tough pair of gloves that fits without much excess material to protect your hands from sharp rasps, knives, or other tools - we will not have extras on hand.
- ❖ Trimming tools if you own some, not mandatory, but if you have them you can become more comfortable with the tools that you will work with in the future.
- ❖ Comfortable shoes, preferably steel toed boots, to protect your feet - NO OPEN TOED SHOES OR FLIP FLOPS PERMITTED!!!
- ❖ Long pants (jeans preferred) - these will likely get dirty, plan accordingly!
- ❖ Folding chair(s) if you think you need one - we have chairs for the lounge during lecture time, but there will be some down/observation time during the trim portions.
- ❖ Good attitude and an open mind!

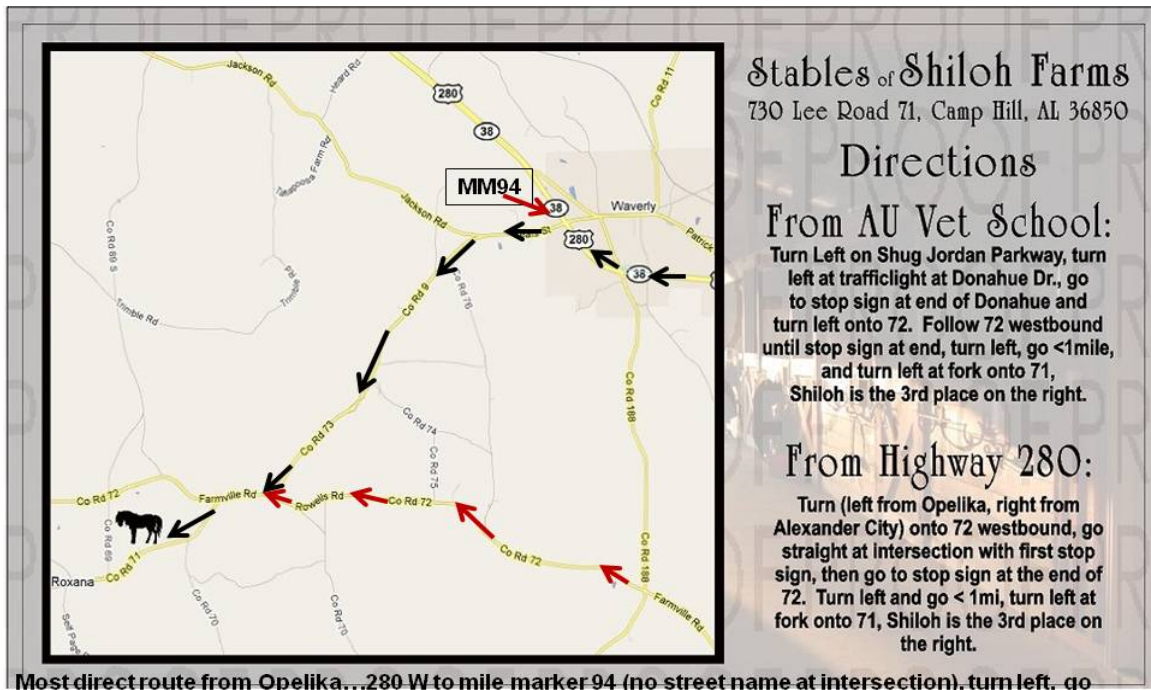
### Directions

#### From AU Vet School:

Turn Left on Shug Jordan Parkway, turn left at trafficlight at Donahue Dr., go to stop sign at end of Donahue and turn left onto 72. Follow 72 westbound until stop sign at end, turn left, go <1mile, and turn left at fork onto 71, Shiloh is the 3rd place on the right.

#### From Highway 280:

Turn (left from Opelika, right from Alexander City) onto 72 westbound, go straight at intersection with first stop sign, then go to stop sign at the end of 72. Turn left and go < 1mi, turn left at fork onto 71, Shiloh is the 3rd place on the right.



**Most direct route from Opelika...280 W to mile marker 94 (no street name at intersection), turn left, go about 4 miles to fork in road with county dumpster (bear left at first fork that you will see within the first 1/2 mile on this road), bear left onto 71, 3<sup>rd</sup> place on right.**

# RELEASE FROM LIABILITY

I, \_\_\_\_\_ do hereby: RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE THE STABLES OF SHILOH FARMS and/or KATRIN KLEMM and/or HIGHER STANDARDS EQUINE, LLC., and/or any trainer, clinician, their operators, horse owners, investors, and each of them, their officers, agent employees, lessees, and participants (all hereafter collectively referred to as RELEASEES) for any event in which I participate voluntarily and which causes the UNDERSIGNED injury, death, damages, or property damages. I HEREBY COVENANT to hold RELEASEES harmless and indemnify RELEASEES for any claim, judgment or expense, including attorney's fees and costs of litigation RELEASEES may incur arising out of my activities or presence, or travel to or from, at or on the farm or on the property of RELEASEES or at horse shows or other horse related events.

I UNDERSTAND that my entry onto the farm or premises of RELEASEES, riding, trimming, showing, spectating, or attending horse shows is intentional, completely voluntary and involves DANGER AND RISK OF INJURY OR DEATH; that conditions for horseback riding and horses change from time to time and may become more HAZARDOUS; and that there is INHERENT DANGER in horses and riding, as well as spectating, which I appreciate and VOLUNTARILY ASSUME BECAUSE I CHOOSE TO DO SO after weighing the risks and benefits of doing so carefully. I have observed horses, trimming, and riding of the type that I seek to participate in and have inspected the grounds, horse, and equipment provided and deem these to be safe by voluntarily participating. I further know that other riders, horses, and participants pose a danger to me; nevertheless, I VOLUNTARILY ELECT TO ACCEPT ALL RISKS connected therewith and/or my participation. I am fully aware and acknowledge that horse events involve inherent dangerous risks of loss and serious bodily injury including, but not limited to head, foot, and back injuries, trauma, broken bones, pain and suffering, or death (herein referred to as 'harm'). I further agree that I expressly assume all risks of harm to my horse or I, including any harm resulting from alleged negligence of Katrin Klemm, Higher Standards Equine, LLC and its releases. I hereby disclose that I, being thoroughly aware of my own body/back condition, elect to voluntarily participate in riding/trimming/grooming or horse handling (whether of my own, barn owned horses or those owned by others) on my own accord, without coercion or force, and am aware that said activity is strenuous and may result in injury, back or other body pain, or even death.

I am aware that I am attending an introduction to hoof trimming clinic intended to give an overview of barefoot hoof trimming, and not intending by any means to make a seasoned independent trimmer out of anyone in one clinic session. I am aware that becoming a proficient and seasoned trimmer takes time, exposure to hoof pathology, exposure to varied methods, and extensive practice, and I hold harmless and indemnify all instructors at said trimming clinic for the limited information provided that I may knowingly or unknowingly apply appropriately or inappropriately to my or other's horses in the process of trimming for personal or professional use. I am aware that the method of trimming elected to be demonstrated in this learning experience is elected based on the instructors' personal experiences and opinions, and does not necessarily represent the only or best method in all circumstances. It is my ultimate responsibility to evaluate available information and assess the appropriateness of the presented trim in any and all circumstances.

I authorize and allow Higher Standards Equine, LLC the free use of any and all photographs obtained of myself and/or my horse during this or future educational events for educational or promotional purposes.

I verify that no representations or inducements have been made to me to sign this RELEASE. I further expressly agree that the foregoing RELEASE, WAIVER, AND INDEMNITY AGREEMENT is intended to be as broad and inclusive as permitted by the law of the state of Alabama in which I choose to participate in activities conducted by the RELEASEES and that if any portion thereof is held invalid it is agreed that the balance shall, notwithstanding continue in full legal force and effect.
